## JUDGE WELSH LEAVES AFTER 22 YEARS OF SERVICE TO CLAY COUNTY

Judge James E. Welsh accepted a job the Missouri Court of Appeals, Western District that existed due to the retirement of Edwin H. Smith. Judge Welsh left his position as a circuit judge on the 7<sup>th</sup> Judicial Circuit (Clay County) and Judge of the Juvenile Division on October 31, 2007. A reception was held in his honor on that date. He will be sorely missed.

The Oath of Office Ceremony occurred on

November 5, 2007. He is the 57<sup>th</sup> Judge appointed to the Appeals Court.

Judge Welsh was named an associate judge in Clay County, Missouri in 1985. In 1988 he was appointed as a circuit judge and took over the job of Judge of the Juvenile Division in 1991.
