UPCOMING 1ST ANNUAL CARDINALS FOR CASA HOMECOMING 5K RUN

THE FORGOTTEN CHILDREN CAMPAIGN



According to the National CASA website, the goal of the Forgotten Children Campaign is to increase the number of children served by CASA volunteers. National CASA kicked off the campaign with an exhibit in Washington D.C. in May in an effort to draw public attention to forgotten children. For one workweek, each day CASA staff, volunteers and supporters placed 850 life-size displays of foster children at the Washington Monument.

These displays represented the 850 children who enter the foster care system each day. By the end of the week, 4250 displays stood in front of the Washington Monument, representing the children who entered foster care that week. Each child display held a placard with a message and a call to action (such as "My CASA is always there for me", "Foster children should be seen and heard" etc.). Six versions of the child displays

illustrated the diversity of children in foster care. The campaign will continue for a year, helping to raise awareness on a local level for CASA programs across the nation. The overall goal is to help raise \$2.9 million that will go to fund local program growth and sustainability. Ultimately, National CASA hopes to use these funds to help provide a caring volunteer advocate to an additional 75,000 abused and neglected children.

JUDGE ROBERT KENNETH ELLIOTT'S LEGACY LIVES ON

On September 12, 2007, Judge R. Kenneth Elliott went to be with the Lord. According to his obituary, he served as a judge in Division II of the 7th Judicial Circuit of Missouri (in Clay County, MO.) for 33 years. He was appointed as judge of the newly formed Division II by Governor James T. Blair in March of 1958. He won his election that year and served from 1958 until mandatory retirement at 70 years of age in 1991. He was the juvenile judge for 28 of those years. He was known as a fair but demanding judge. He had a deep respect for the judicial system and for the people he served. He was a lifelong student of the law, and sought to wisely apply it in every case. During the three decades he served as judge, he had a positive effect on the lives of countless Clay County citizens,

especially the young lives he helped in juvenile court. He always worked to improve the juvenile justice system. He was a former president of the National Juvenile Judges Association, and he led the drive in the 1970's to acquire the first Clay County juvenile facility to keep young people separate from adult detainees. In 1996, after his retirement, the current juvenile facility was erected and named in his honor, The R. Kenneth Elliott Children's Justice Center. In 2003 he received the first Alexander Doniphan Community Service Award in Clay County. It was noted that "his great vision, coupled with his love for people and commitment to justice, made him an ideal recipient for this award." Judge Elliott was described as "a paragon of professionalism and human decency." He was instrumental in developing the CASA Program in Clay County, MO. He will be missed.
