In accordance with the authority vested in this court by the laws of the State of Missouri, you are hereby placed on probation for such period of time as stated herein or until you have proven by your conduct, to the satisfaction of this Court, that you are entitled to discharge from this probation. You are hereby advised that under the law the Court may at any time revoke or modify any conditions of the probation, and you shall be subject to arrest upon order of the Court. At any time within the period of your probation the Court may impose or order execution of sentence for your original offense in accordance with the laws of the State of Missouri, and commit you to a penal institution as provided by law.

If supervised, it is further ordered that your case be assigned for supervision to the office outlined and its representative Probation Officer, or to the Court. That office is authorized to report to this Court on all matters pertaining to your probation, and to make such recommendations and take such action as the Court may require.

You are subject to the following general conditions (1-6), and special conditions which are checked, as follows:

1. **LAWS:** I will obey all federal and state laws, municipal and county ordinances. I will report any arrest to my Probation Officer within 48 hours. This includes traffic arrests. I will NOT drink and drive, and will submit to a breath or blood test upon the request of a Law Enforcement Officer.
2. **RESIDENCE:** I will notify my Probation Officer of any changes in residence in writing within 7 days.
3. **EMPLOYMENT:** I will obtain advance permission from my Probation Officer before quitting my job or program. In the event I lose my job or am terminated from a program, I will notify my Probation Officer within 48 hours.
4. **ASSOCIATION:** I will not associate with any person who has been convicted or placed on probation for a felony. It is my responsibility to know with whom I am associating.
5. **DRUGS:** I will not possess or use any controlled substances except as prescribed for me by a licensed medical practitioner.
6. **REPORTING/DIRECTIVES:** I will report as directed to my Probation Officer, I agree to abide by any directives given to me by my Probation Officer.
7.  **JAIL TIME:** I will serve \_\_\_\_\_ hours/days in the Clay County Jail. Jail time to commence at \_\_\_\_\_ m. on \_\_\_\_\_.
8.  **COMMUNITY SERVICE:** I will perform \_\_\_\_\_ hours of community service under the supervision of Northland Alternative Service Program or \_\_\_\_\_ and will abide by any directive given me concerning same, and pay the fees.

to.  **IGNITION INTERLOCK:** I will have an Ignition Interlock device installed on any vehicle that I operate during the period of probation, and pay the fees.

11.  **COSTS:** I will pay all fines, costs and fees associated with this and any companion cases on or before \_\_\_\_\_ at (9:00 a.m.) (1:30 p.m.)  
Failure to appear on the date above to make payments or show good cause why I cannot pay will result in a warrant for my arrest and possibly jail sentence for contempt of Court and/or revocation of probation.
